**PROMOTION DESCRIPTION:** The “Kenny Chesney’s The Big Revival Tour” Sweepstakes (the “Sweepstakes”) begins on or about May 18, 2015 at 12:01 a.m. Eastern Time (“ET”) and ends on June 14, 2015 at 11:59 p.m. ET (the “Promotion Period”). At the end of the Promotion Period, a random drawing will be conducted to select two (2) winners of a Grand Prize from among all eligible entries received, as set forth more fully below. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of CID Entertainment, LLC (“Sponsor”), which shall be final and binding in all respects.

**ELIGIBILITY:** Only legal U.S. residents of the fifty (50) United States and District of Columbia located in the U.S. at the time of entry who are eighteen (18) years of age or older at the time of entry are eligible to enter. Sponsor, TI Media Solutions Inc., People Magazine, Kenny Chesney and each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies, artist partners and each of their respective officers, directors and employees (collectively, the “Promotion Entities”), and each of their immediate family members and/or people living in the same household are not eligible to enter the Sweepstakes or win a prize. Upon completion and submission of the entry form, you will automatically be entered. **Limit one (1) entry per person and/or household and/or e-mail address.** All entries must be received by the end of the Promotion Period in order to participate. The Website’s database clock will be the official time keeper for this Sweepstakes. All required information on the entry form must be completed to enter and to be eligible to win. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of such entry. Except as otherwise contemplated in these Official Rules, and to the extent entrants may otherwise elect at the time of entry, personal information collected in connection with the Sweepstakes will be used in accordance with Sponsor’s privacy policy located at [www.cidentertainment.com/privacy-policy](http://www.cidentertainment.com/privacy-policy).

NOTE: Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. Tampering with the entry process or the operation of the Sweepstakes, including but not limited to the use of any device to automate the entry process, is prohibited and any entries deemed by Sponsor, in its sole discretion, to have been submitted in this manner will be void. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor’s satisfaction, the affected entry

will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

**WINNER SELECTION AND NOTIFICATION:** At the end of the Promotion Period, the winners (one winner for each Event) will be randomly selected in a drawing from all eligible entries received throughout the Promotion Period. The drawing will be conducted by Sponsor or its designee, using randomization methods selected by Sponsor in its sole discretion. A potential winner will be notified by telephone and/or mail and/or e-mail using the contact information given at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. **Time is of the essence in awarding each prize.** If, despite reasonable efforts, a potential winner does not respond within five (5) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. If any potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected. Sponsor may successively attempt to contact up to two (2) potential winners of a prize in accordance with such procedure, and if there are still no confirmed winners of such prize after such attempts have been made, if any, such prize may go unawarded.

**PUBLICITY RELEASE:** By participating in the Sweepstakes, in addition to any other grants which may be granted in any other agreement entered into between Sponsor and any entrant in and/or winner of the Sweepstakes, each entrant irrevocably grants the Promotion Entities and their respective successors, assigns and licensees, the right to use such entrant's name, likeness, and biographical information, and any other personal characteristics, in any and all media for any purpose, and each entrant and/or prize winner hereby release the Promotion Entities from any liability with respect thereto.

**PRIZES/ODDS:** There are two (2) Grand Prizes available.

Each Grand Prize consists of one (1) package for a Kenny Chesney concert at either the Rose Bowl in Pasadena, CA on July 25, 2015 or MetLifeStadium in East Rutherford, NJ on August 15, 2015 (each, an **"Event"**) (as selected by Sponsor) that includes the following:

  - One (1) early admission General Admission Sandbar ticket OR one (1) Premium Reserved ticket (TBD by Sponsor)

  - Admission to the Time Flies Exhibit – a private display of Kenny Chesney memorabilia that travels with the tour, only available to VIP guests and guests of Kenny Chesney
  - One (1) Kenny Chesney merchandise gift
  - One (1) limited edition Kenny Chesney tour poster
  - One (1) VIP laminate
  - One (1) parking pass per order
  - Dedicated VIP concert concierge
- One (1) Meet & Greet for the winner and his/her companion with Kenny Chesney at or in connection with one (1) of the Events

- Round-trip coach class airfare for two (2) between the major airport that is nearest to the winner's residence and an airport selected by Sponsor near the applicable Event
- One (1) night hotel accommodation (one [1] room, double occupancy)

The total approximate retail value (“ARV”) of each Grand Prize is One Thousand Nine Hundred Dollars (\$1,900.00).

There is no guarantee that a winner's preferred Event location will match the Event location awarded. No cash alternative or substitution of prizes will be allowed, except Sponsor reserves the right in its sole discretion to substitute prize(s) of comparable value if any prize listed is unavailable, in whole or in part, for any reason.
